Tapestri Inc. is dedicated to ending violence and oppression in refugee and immigrant communities.

Tapestri is first and foremost focused on the people we serve, their families, and their communities. We believe the first step to rebuilding our clients' confidence is to help them escape from the fear in their lives brought about through forced labor, domestic violence, and commercial sexual exploitation is the first step in rebuilding our clients' confidence.

Since 2002, Tapestri has provided care, hope, and answers for foreign born survivors of human trafficking and domestic violence and for the communities where they have built their new homes.

Tapestri is dedicated to ending violence and oppression in the refugee and immigrant communities by using culturally competent and appropriate methods.

We have worked closely with survivors and seen how eager they are to become self-sufficient but often lack the basic language skills necessary to obtain a job and live independently. They strive for a better life where they can achieve self-sufficiency and often find they are unable to free themselves from exploitation and abuse.



Tapestri serves both men and women who have experienced miserable life situations that many of us cannot imagine.

We partner with other agencies to help our clients attain increased job skills, living wage job placements, and opportunities for career advancement. We lead them through a mutually-agreed upon life skills development plan where they can begin to reintegrate into society.

At a time when the number of U.S. cases of human trafficking is continuing to grow, we are proud to remain at the forefront of the response as we enter our 15th year of providing direct services to those in need. In our city of Atlanta, the U.S. Department of Justice named Atlanta "top city for human trafficking." Over the past two years, Tapestri has

assisted 94 human trafficking survivors in the state of Georgia and according to the U.S. Department of Justice the number of cases of human trafficking will continue to rise. As individuals begin to experience and understand the impact of our work, we hope to realize growth in philanthropy to support our current services and to develop new service areas.

We thank our volunteers, donors, and partners who invest in what we do. Our name, "Tapestri," symbolizes the different threads of society coming together to form a safe cover to protect our dierse community. Thanks to your support, our life saving work goes on.


